Any rule changes will be either published, or participants will be advised prior to competing.

All **MYHEC** participants and coaches are responsible to be knowledgeable of all event rules, regulations and contents for this program manual.

Use of cell phones (or other prohibited electronics) by participants, parents and/or coaches will lead to immediate disqualification at the event participating in. Second offense will be disqualification from event. No awards will be awarded to persons who have been disqualified in any event.

#### I. INTRODUCTION

#### **About MYHEC**

The Michigan Youth Hunter Educational Challenge (MYHEC) is a National Rifle Association of America (NRA) and the International Hunter Education Association (IHEA) program sponsored event and is open to any youth who has successfully passed a Hunter Safety Course and is in possession of a valid Hunter Safety Certificate; has <u>not</u> reached their nineteenth (19) birthday on or before August 1st of current year.

Participants in the Michigan Youth Hunter Educational Challenge (MYHEC) are also eligible to register and attend the NRA International Youth Hunter Education Challenge for the current year; which is conducted annually. Location and dates are announced by the National Rifle Association.

#### **MYHEC EVENTS**

The MYHEC program is divided into eight (8) events or activities:

#### Four (4) Shooting Events –

- 1. Hunting Archery Challenge
- 2. Hunting Muzzleloader Challenge
- 3. Hunting Shotgun Challenge
- 4. Light Hunting Rifle Challenge

#### Four (4) Responsibility Events –

- 5. Hunter Responsibility Exam
- 6. Hunter Safety Trail Challenge
- 7. Hunting Orienteering Skills Challenge
- 8. Hunting Wildlife Identification Challenge

The Michigan Youth Hunter Educational Challenge (MYHEC) operates all eight (8) events and participants are expected to participate in all eight (8) events. It is the goal of our program to provide training, knowledge and experience in all phases of the hunting and shooting activities. A limited number of shotguns, rifles, bows and muzzleloaders are available for participants to use; however, it is **strongly recommended** that individuals provide their own equipment.

#### **II. SAFETY RULES**

#### Safety is Shooting's Most Important Rule

These rules provide for the efficient and orderly operation of the NRA Youth Hunter Education Challenge (YHEC) and have been adopted to be used at the Michigan Youth Hunter Education Challenge (MYHEC). Many local range regulations exist for one reason alone – **SAFETY.**Others serve a dual purpose – smooth range operation and safety.

It's your responsibility as a participant, as a coach or as a MYHEC official to become familiar with the rules and to know the meaning behind those that are safety-oriented.

#### **Event Safety Rules**

- I. Actions of uncased firearms MUST always be open with an empty chamber indicator (ECI) inserted in the chamber except when on the firing line, ready to fire.
- II. Guns are to be unloaded except when on the firing line, ready to fire.
- III. Arrows will not be nocked until on the firing line.
- IV. All firearms must have a safety device with the exception of traditional muzzleloaders. The safety will remain on at all times except when ready to fire.
- V. All firearms will be pointed and bows drawn in a safe direction at all times.
- VI. Know and obey all range commands. Arrive at each activity at least 15 minutes prior to relay time in order to receive proper activity orientation.
- VII. ONLY one shell or cartridge may be placed in a firearm at a time, UNLESS otherwise specified in the rules for the activity or by the Event Director.
- VIII. All participants and officials must wear adequate eye and ear protection while on the firing line.
- IX. All ammunition will be provided by the MYHEC. Absolutely nobody, other than a MYHEC official may be in possession of ammunition. Ammunition consists of all Shotgun, rifle and muzzleloader shells, powder, or cartridges.
- X. Firearms and bows MUST be transported in a case when going to and from events.
- XI. Firearms and bows not in use at event sites MUST be placed in a gun/bow rack (rifles w/ ECI inserted in chamber).

#### **Gun Safety Rules**

#### The fundamental NRA rules for safe fun handling are:

- 1. Always keep the gun pointed in a safe direction.
- 2. Always keep your finger off the trigger until ready to shoot.
- 3. Always keep the gun unloaded until ready to use.

#### Then using or storing a gun, always follow these NRA rules:

- 4. Know your target and what is beyond.
- 5. Know how to use the gun safely.
- 6. Be sure the gun is safe to operate.
- 7. Use only the correct ammunition for your gun.
- 8. Wear eye and ear protection as appropriate.
- 9. Never use alcohol or drugs before or while shooting.
- 10. Store guns so they are not accessible to unauthorized persons.
- 11. Be aware that certain types of guns and many shooting activities require additional safety precautions.

Be aware that certain types of guns and many shooting activities require additional safety precautions.

Protection of your sight and hearing are **YOUR** responsibility. Wear adequate eye and ear protection while on the firing line – as a shooter, official, or spectator.

To learn more about gun safety, enroll in a NRA safety training or basic marksmanship course, NRA hunter clinic or state hunter education class.

#### **Archery Safety Rules**

#### The fundamental rules for safe archery/bow handling are:

- 1. Do not nock an arrow on the bowstring until ready to use.
- 2. Always keep a bow with a nocked arrow pointed in a safe direction.
- 3. Never draw a bow with nocked arrow until ready to shoot.
- 4. Always keep field points or broadheads\* covered until ready to use.
  - \*Broadheads are prohibited in the YHEC (and MYHEC) program.

#### When using or storing a bow, always follow these rules:

- 1. Be sure the bow is safe to operate.
- 2. Know how to safely use the bow and its equipment.
- 3. Use only the correct arrows and equipment for your bow.
- 4. Never use alcohol or drugs before or while shooting.
- 5. Store bows and other archery equipment so they are not accessible to unauthorized persons.
- 6. Never dry-fire a bow.

#### III. PARTICIPATION GUIDELINES

#### **Eligibility for Participation in the NRA MYHEC**

The 2018 MHEC event will be held at the Capital Area Sportsmen League in Lansing, Michigan on August 18-19, 2018.

#### Participation in the MYHEC event is open to:

- Any person, 18 years old or younger, as of August 1st for the current event year, who is interested in attending the Michigan Youth Hunter Challenge. Participants may register as individuals or with a five (5) member team. *Individuals may register only once and are not allowed to be a member of more than one team*.
- > All participants must have successfully completed a hunter education course in North America.
- All participants are required to provide a copy of their Hunter Safety card when submitting registration form to participate in the MYHEC. ONLY participants who have a copy of their hunter safety card on file with the MYHEC organization on the day of the event shall participant in the MYHEC event.
- Registered participants are encouraged to participate in all eight (8) events of the MYEHC event Archery, Muzzleloader, Rifle, Shotgun, Hunter Safety Responsibility Exam, Hunter Safety Trail, Orienteering and Wildlife Identification. However, for an individual's score to be eligible to receive medals, they must have completed all four (4) responsibility events; Hunter Safety Responsibility Exam, Hunter Safety Trail, Orienteering and Wildlife Identification. (Note: Responsibility events are considered the tie breaking events.)
- > Persons /Teams participating in the MYHEC must have:
  - o at least one (1) sponsoring adult for an individual or team
  - Teams must have five (5) members with one (1) sponsoring adult per every five (5) member team. Members of teams will be eligible for individual awards and recognition.

#### **Registration Options:**

Option 1 - Register as an individual only. Individuals may be grouped with other individual registrants into a five (5) person team in order to provide for efficient operation of the State Event. Teams created in such fashion will be at the discretion of the State Event Director, or registrar. Such teams will be comprised of individuals within the same age category and they will be eligible for all team and individual awards. In case there is not a sufficient number of individuals to form a complete five (5) member team, individuals will be formed into a team of less than five (5) and will compete for team awards with less than five (5) members.

#### Option 2 – Register a participant as a team member.

A team may include up to five (5) members. Scores from registered team members will be compiled resulting in "team aggregate scores."

#### **Registration Requirements:**

- All registration forms and fees must be submitted and received by MYHEC staff no later than the late registration date.
- All registrants are required to provide a copy of their Hunter Safety card prior to the MYHEC event along with their registration form.
- All registered participants are required to participate in all eight (8) events of the MYHEC.

#### **MYHEC Divisions**

The NRA Michigan Youth Hunter Educational Challenge will use the following Divisions.

#### A. Divisions

1. **Junior Division** (14 years of age and under)

Participants who are 14 years of age and under, on or before August 1st of current event year, may enter in the Junior Division.

Participants who are eligible for entry in the Junior Division, may upon their election request to be placed on, or as a member of a Senior Team. Individuals will score for individual Junior Awards. Their scores will be part of the aggregate team score and be counted as a member of a Senior Team. Such cross registrations are at the sole discretion of the MYHEC staff.

2. **Senior Division** (15 through 18 years of age)

Participants ages 15 through 18 years of age, on or before August 1st of current event year, may enter in the Senior Division.

Senior participants MAY NOT be registered as part of a Junior Team.

NOTE: Individuals may not alter their participation division or team members after midnight on August 10, 2018. (Also see Section IX, Entries and Cancellations for MYHEC Participants.)

#### IV. PROGRAM REGUALTIONS AND CODE OF CONDUCT

# **Safety** will be the first and foremost consideration during all MYHEC activities.

- Participants and spectators assume all risk of personal injury or property damage as noted on the required release form located on the back of the registration form.
- Participants violating any safety rule as established within these program rules and regulations, or as stated by MYHEC Officials, will be given one warning and face disqualification from further participation should a second infraction occur. If the safety violation is severe (at the discretion of MYHEC officials), the participant may not be given a warning, but may be subject to disqualification and removal from further participation. In addition, it may be required to remove the individual from the facility.
- Participants should provide their own firearms, bows and arrows, compasses and eye and ear protection. The MYHEC may provide limited equipment (muzzleloader rifles, shotguns, .22 rifles) if available, and should circumstances merit. If such equipment is provided, by either the MYHEC program or other individuals the participant will not be allowed additional time or provide for sight-in of borrowed equipment.
- Individuals many not participate for one another in any activity.
- Participants are expected to exhibit behavior above reproach at all times.\*

**Safety** is everybody's concern. Any unsafe act(s) or condition(s) may be addressed so as not to endanger individuals. Please bring all safety concerns to the MYHEC State Event Director, or the NRA State YHEC Coordinator, as well as any Event Leader or Volunteer.

#### \*NOTICE

All participants and parents/guardians must sign a release regarding program regulations and code of conduct before the event. This is found on the backside of the registration form.

#### **NRA Code of Conduct**

(Adapted in full for MYHEC Event)

Program regulations governing conduct for all attendees at the NRA Michigan Youth Hunter Education Challenge (MYHEC) State Event: staff, participants, coaches, volunteers, spectators, etc.

The following regulations and conduct codes are to be adhered to at all times during the MYHEC event.

#### It is understood that each participant will:

- 1. Always follow NRA'S rules of firearms safety.
- 2. Participate fully in all activities.
- 3. Fully cooperate and comply with all established rules and regulations, and reasonable requests made by MYEHC officers, officials, directors, event leaders, and volunteers.
- 4. Know and follow all local, state, and federal laws.
- 5. Know and follow all rules pertaining to the event(s) in which you are participating.
- 6. Respect others and their property at all times.
- 7. Exhibit high moral and ethical standards.
- 8. Notify administration when situations occur that require attention.
- 9. Always dress in appropriate attire. Recognizing the publicity attracted by the NRA and its programs, it is important to promote a positive image for the hunting and shooting sports. Clothing worn during the MYHEC event should be tasteful and appropriate for this type of event. Articles of clothing featuring controversial, questionable or offensive illustrations, slogans or language are prohibited. NRA officers, employees, and Event Directors are empowered to take action necessary to maintain acceptable clothing standards.

## It is further understood that staff, participants, coaches, volunteers, and /or family members are PROHIBITED From:

- Possessing and consuming alcoholic beverages, and/or illegal drugs/narcotic substances, tobacco products or electronic cigarettes (e-cigs) during the MYHEC program. Use of tobacco and e-cig products may be used in designated areas only for persons of legal age. Smoking is <u>fully prohibited</u> in, around and near the Muzzleloading event.
- 2. Keeping ammunition in their housing units/areas. All ammunition will be provided by MYHEC.
- 3. Going to, observing, and/or evaluating as event before actual participation. It is also prohibited for parents, coaches, spectators or other individuals from advising participants, or coaches about the setup, layout, or any other information in which would enhance the participants performance in a particular event prior to their participation in that event.
- 4. Videotaping, taking still photographs, or written, recorded notes with the intent of showing participants (and/or coaches, non-participants, spectators), event layouts.
- 5. Using physical gestures and/or electronic equipment (i/e. walkie talkies, pagers, two-ways, beepers, cell phones and cell/camera phones or other messaging/communications equipment with the intent of assisting individuals participating in events.
- 6. Communicating in any manner with a participant performing in an event with the intent to assist or coach that individual so as to improve their performance in the event.
- 7. Coaching (or attempted coaching) from spectator area(s).

Failure to comply with the NRA Code of Conduct may result in immediate and permanent expulsion of individual(s) from the MYHEC.

#### NOTICE

All participants and parents/guardians must sign a release regarding program regulations and code of conduct before the event. This is found on the back side of the registration form.

#### V. EVENT RULES & REGUALTIONS

#### **Rules and Regulations for Shooting Events**

#### 1. Hunting Archery Challenge

- a. Participants will move through a *thirty (30) point* archery course in a natural setting whenever possible. The course is designed to simulate shooting situations encountered while bowhunting.
- b. The Hunting Archery Challenge will be conducted with participants taking shots at targets varying in distance (from 10 to 40 yards). Targets will be either NRA life-size game targets or 3-D game targets with scoring areas directly over the vital areas of the animal.
- c. Scoring Each participant will shoot a total of 30 shots. All shots breaking or touching the vital area will be counted as a "hit." Shots touching leg or antler areas will not count as "hits." Challenges must be made on the range before the next arrow is pulled. The Hunting Archery Challenge has the maximum possibility of 300 points. NOTE: A time limit of up to 45 seconds can be applied at each station. Time limits on some targets may vary depending on shooting station requirements. Participants will be advised of time limit change upon arrival at shooting station.

## d. Archery Equipment

#### Required

- Shooters may use only one bow throughout this activity (exception bow malfunction).
- ➤ Bring your own arrows. It is suggested you bring no fewer than 12 arrows and is HIGHLY RECOMMENDED that you bring 30 arrows if you feel you will not be able to retrieve lost arrows quickly. Applies even if you will be using a loaner bow and want to use a matched set of arrows. (Refer to Available at Archery Event Section below.)
- ➤ All arrows must have either glue on or screw in target or field points.
- All arrows **MUST** be in a quiver (i.e. hip or bow quiver) while being transported between stations.
- ➤ It is **HIGHLY RECOMMENDED** that all participants use armguards and finger tabs.

#### **Permitted**

- Only hunting-type compounds, recurves or long bows will be permitted.
- Bows may be equipped with hunting-type sights.
- Self-adjusting sights (i.e. Sightmaster).

#### **Hunting Archery Challenge, Con't.**

#### **Available at Archery Event**

- MYHEC has a limited number of **low** poundage bows, arrows, arm guards, finger tabs, and quivers available for loan. Loaner equipment will be available at a first come first serve basis.
- Participants using loaner equipment will be responsible for returning **ALL** equipment loaned including arrows. If not returned, you will be charged a fee for missing equipment when you return to registration table. (i.e. Cost of arrows will be determined on the day of the event, estimate \$6 \$8 each)

#### **Prohibited**

- Sky Drawing
- Cable stops
- Extended sight bars that measure farther than six (6) inches from the back of riser of bow to front of sight.
- Manually adjustable sights may have no more than six sight pins or be adjusted to more than six sight positions
- More than one (1) stabilizer
- > Stabilizers over twelve (12) inches
- Range finders
- Binoculars, monocular or spotting scopes
- Crossbows (Exception: Those who are legally handicapped and have a legal crossbow permit.)
- Broadhead hunting tips
- Arrow shafts that do not have target or field points
- Sights that have lens with or without magnification
- ➤ Shocker & Bludgeon Points
- Globes, cross hairs or other target sights are not permitted

#### **MYHEC Archery Rules**

On the next page

#### **MYHEC Archery Rules**

(Presented to participants before entering the course)

- 1. No range finders or binoculars allowed on the course
- 2. There will be no smoking on the course. This is for parents and coaches as well.
- 3. No broadheads, field tips only.
- 4. There will be 10 stations, 3 targets per station, shoot 1 arrow per target, for a total of 30 targets. The scoring will be 10, 5, and 0.
- 5. Do not shoot at any targets until instructed to do so. The commands will be: CLEAR, NOCK ARROW, SHOOT.
- 6. No 'sky drawing' is permitted; penalty may include a warning or disqualification.
- 7. Do not retrieve arrows until instructed to do so. Do not pull arrows until they have been officially scored. Place one hand on the target, the other hand on the arrow and pull straight out. If necessary please put target back together or straighten it.
- 8. Challenges must be made on the range before the next arrow is pulled.
- 9. No running on the course.
- 10. Be aware of where you are and where your group is when looking for your arrows. Please do not go backwards on the course and possibly into the path of oncoming shooters.
- 11. Parents and coaches are allowed on the course this year. However, no coaching is allowed. If you do, you will be asked to leave the course, Help is appreciated looking for lost arrows but please don't crowd around the targets while the participants and scorer are scoring.
- 12. Stay well behind the shooting line when someone else is shooting. Also, please be quiet when others are shooting.
- 13. Arrows must be pointed down range at all times. All arrows MUST be placed in a quiver while moving from on station to the next.
- 14. If you have a cell phone or pager, please turn it off while on the course. Coaches and parents as well.
- 15. No food is allowed on the course!
- 16. Please don't leave without signing your score cards after you are finished shooting.
- 17. Above all else, be safe! Have Fun!!!

#### 2. Hunting Muzzleloader Challenge

NOTE: Smoking is PROHIBITED on, near, or around this venue.

NO open cans of powder will be allowed on the firing line or loading bench.

- a) Participants will shoot the muzzleloader course in a natural setting or a range course. The course is designed to simulate shooting situations encountered while hunting.
- b) The Hunting Muzzleloader Challenge will be conducted with participants shooting at NRA life-sized game targets or NRA-approved action targets. "Clangor" targets may also be utilized. When this style of target is used, striking the designated area with a shot will be considered as a "hit". "Hits", when using clangor targets will be at the determination of the MYHEC scoring official. Participants will shoot from three positions at three different distances; short range, medium range and long range. The Hunting Muzzleloader Challenge has the maximum possibility of 300 points.

<u>Position one (1) – (short range)</u> may have a distance of 35 yards or less. Participants will shoot from a standing position with no props permitted at these distances or position.

**Position two (2) – (medium range)** may have a shooting distance of 50 yards or less. Participants may use any shooting position (excluding prone).

<u>Position three (3) – (long range)</u> may have a shooting distance of 75 yards or less. Participants may use any shooting position and only props provided by the event director.

c. **Scoring** – Participants will shoot a total of twelve (12) shots worth twenty-five (25) points, four (4) from each of the three (3) different positions. Movement of the flag has to be a full swing to count as a hit. <u>Any call to challenge must be made before proceeding to the next station.</u> The Hunting Muzzleloader Challenge has a maximum possibility of 300 points.

NOTE: A written test is given at the International YHEC event and these are the resources listed that you may use for preparation.

# d. Muzzleloader Equipment Required

Shooters may use only one muzzleloader rifle throughout this activity (exception

– muzzleloader malfunction).

#### Hunting Muzzleloader Challenge, Con't.

#### **Permitted**

- ➤ Any flintlock, disk, percussion, musket cap or 209-primer type muzzleloading rifles .54 caliber or smaller will be permitted.\* (Refer to Available at Muzzleloader Event Section below)
- Muzzleloading rifles will utilize granulated pyrodex or black powder, or pellets
- Projectiles will be round-ball or pure lead bullets only.
- Muzzleloaders may have a set trigger BUT may not to be set until ready to fire.
- Muzzleloaders may be equipped with sporter type thumbhole stocks (non-adjustable).
- ➤ Muzzleloaders may be equipped with a sling not to exceed 1 ½ inches (3.81 centimeters) in width.
- Muzzleloader sights will open, peep, hooded or tunnel with standard front post and bead.
- Muzzleloaders may be loaded with single projectile patched balls or pure lead bullets.
- Participants are allowed to use their own accessories, however all accessories MUST be turned in at registration and inspected by event officials prior to participation. Caps to be used MUST be presented to range officials.

#### **Available at Muzzleloader Event**

- \*Accessories for .50 caliber muzzleloaders will be available for use during the event. Participants choosing to use another caliber (i.e. .45 or .54) are required to furnish their own accessories and round balls; these MUST be turned in at registration.
- ➤ MYHEC will provide .50 caliber round balls for utilization at the State Event, as well as Black Powder or Pyrodex.
- ➤ A limited number of traditional muzzleloader rifles are available at the Muzzleloading event.

#### **Prohibited**

- Shooting mats
- > Binoculars, monoculars, spotting scopes or telescopic sights (optical devices)
- Range finders
- Open cans and/or dispensers of powder on the line
- ➤ More than 60 grains ignition components by volume, per load
- ➤ Pure lead bullets/balls weighing more than 385 grains
- ➤ Kneeling rolls
- > Adjustable competition sling swivels
- Adjustable thumbhole stock (adjustable)
- Any smokeless or nitro cellulose-based powder Muzzleloaders larger than .54 caliber

#### Hunting Muzzleloader Challenge, Con't.

- Wooden ramrods
- > Shooting sticks
- ➤ Metal-Jacketed bullet sabots
- > Sights with crosshairs
- e. **Shooting Procedures** Only participants will be allowed on the station or firing line while shooting each station. The score judge or range officer will oversee firing line, loading bench and the participant as required. The participant will shoot his/her quota of rounds and return the gun to the rack, or move to the next station (with unloaded firearm). This sequence is repeated for each participant until all have completed the activity. Participants will be allowed to clean firearms. The time limit to complete the entire course will be 45 minutes. (NOTE: Times will be at the discretion of the Event Director.)

#### f. Cross Fires (When using NRA Life-Size paper targets)

If a participant's target has been struck by more shots than fired by the participant, that target shall be declared as having been crossfired:

- The event director must determine that the crossfire was unintentionally caused (with no malicious intent) by participants on the firing line. If this is established, the crossfired target will receive the total score of rounds inside the scoring area (not to exceed the maximum score for that round of shooting). The participant committing a crossfire act will only be scored for the amount of rounds inside his/her actual target's scoring area.
- Should the Event Director find that the crossfiring was an intentional act by participants to gain unfair advantage, all parties involved will be immediately disqualified for the event and will subsequently receive "DQ" (amounting to '0") under both individual and team scores. Such individuals also subject to violation of the Code of Conduct and may be subject to disqualification fo the entire State Event.

#### g. Misfires

If a participant's Muzzleloading rifle misfires (fails to fire) as a result of improper loading, (omission of powder, patch, or ball or installing powder, patch, or ball in an improper sequence) that shot shall be determined as a "miss" and a zero is scored for that particular shot. Failure for a percussion cap to detonate, shall not constitute an improper load and misfire, and the participant will be allowed to replace the percussion cap and continue their course of fire.

**EXCPTION:** When using MYHEC rifles you may not be penalized for the **FIRST** miss fire; this decision will be made at the discretion of the range officer. (i.e. the barrel may possible been left too wet by the last participant.)

#### 3. Hunting Shotgun Challenge

- a. When available participants will move through a multiple station Hunter's Clay course whenever possible. This course is not patterned after conventional skeet and trap shooting, but is designed to simulate hunting conditions and situations. The layout will vary depending on the available topography. Shooting stations should make use of available cover to best depict running animals, bird flight, and shooting obstacles. NOTE: Optional courses may utilize trap and/or skeet fields when facility used does not have a sporting clays course.
- b. The Hunting Shotgun Challenge will be conducted with participants taking shots at clay targets. Sizes of the clay targets may vary depending on different situations. Singles and doubles will be thrown. Double targets may be presented as report, following or true pair.
- c. Scoring Each participant will shoot a total of thirty (30) shots, each worth ten (10) points for a hit (broken target) and zero (0) points for a miss (lost target). The Hunting Shotgun Challenge has a maximum possibility of 300 points.
- MYHEC event scoring will be done by designated MYHEC officials. Only legal targets will be scored and the score judge will be sole judge of whether or not a target is broken. Officials may ask assistance from the trap puller or the range official if they feel their assistance is required.
- Scorers will call "lost" for any target they determine is missed. Any challenge to the call must be made immediately by the participant. The final decision will then be made by the score judge with assistance form the trap operator and/or the range official, if required.

#### Scoring Pairs:

Should the participant break both targets with either the first or second shot, they will both be scored as "dead" targets.

In the event of a "no Bird" call on the second target of a report pair, the first bird is established as "dead" or "lost" and the shooter will repeat the pair to establish the result of the second target. When repeating the pair, the shooter must make a legitimate attempt at breaking the first target.

In the event of a "shooter malfunction" on the first target of a report pair, the first target is established as "lost." The shooter will repeat the pair to establish the result of the second target. When repeating the pair, the shooter must make a legitimate attempt at breaking the first target.

#### **Hunting Shotgun Challenge, Con't.**

Rule and/or procedure violations may be referred to NRA staff and officials for settlement, but legality of targets is the responsibility of the score judge. Only targets with a visible piece broken off will be scored "dead". Dusters, targets deflected or redirected in flight (but with no visible breakage) will be scored "lost". Based on the scorer's judgment, should a target hit an obstruction (i.e. tree or tree limb) before the participant has had ample time to fire, anew target will be thrown, However, should the participant have ample time to fire (in the scorer's judgment), and fails to do so before the target hits an object neat the end of its path and breaks, the target will be scored "lost".

- Rule and/or procedure violations may be referred to the MYHEC staff or Protest Committee for settlement, but legality of targets is the responsibility of the score judge. Only targets with a visible piece broken off will be scored "dead". Dusters, targets deflected or redirected in flight (but with no visible breakage) will be scored "lost".
- ➤ Based on the scorer's judgment, should a target hit an obstruction (i.e. tree or tree limb) before the participant has had ample time to fire, a new target will be thrown. However, should the participant have ample time to fire (in the scorer's judgment) and fails to do so before the target hits an object near the end of it's path and breaks, the target will be scored "lost".

#### d. Shotgun Equipment

#### Required

Shooters may use only one shotgun throughout the activity (exception – gun malfunction).

#### <u>Permitted</u>

- ➤ Any shotgun 12 gauge and smaller will be permitted.
- > Double targets will be thrown in some instances; therefore the shotgun should be capable of holding two (2) shells. \* (Refer to Available at Shotgun Event Section below.)
- > Only factory-loaded target shells with shot size between 7 ½ and 9 (inclusive) will be permitted

#### **Available at Shotgun Event**

- ➤ MYHEC will furnish all 12 and 20 gauge ammunition in low brass target loads to every participant. The specific manufacturer and type of loads will be at the discretion of MYHEC administration. Those choosing a gauge other than that detailed above are required to furnish their own shells and MUST be turned in at the time of registration.
- ➤ A limited number of 20 and 12 gauge shotguns will be available to use at the shotgun event.

#### **Hunting Shotgun Challenge, Con't.**

#### **Prohibited**

- Shotguns 10 gauge or larger.
- > Release triggers
- ➤ Shot size larger than 7 ½
- > Shot size smaller than 9
- ➤ Ventilated rib greater than 1/2 inch in height or width
- ➤ Lenses, optics, and illuminated-type sighting fixtures
- Shotguns without safety or safety has been disabled

#### e. Shooting Procedures

- ➤ Each group of shooters may be allowed to see one legal target from each trap prior to shooting the activity at the station.
- Only participants will be allowed on the station or firing line.
- ➤ The score judge or range officer will hand shells to the participant as required.
- The participant will shoot his/her quota of targets and will be instructed by range officer as to whether the gun shall be returned to gun rack or what the proper carry or hold will be appropriate.

The sequence for calling for a target to be thrown is:

- a. The participant will say "trapper Ready."
- b. The trapper will acknowledge.
- c. Upon the trapper's acknowledgement, the participant will say, "Pull."
- d. The trapper will have up to 3 seconds to release the target.

The "ready position" in calling for the target requires the gun to be off the shoulder with the butt plate below the armpit. The firearm may not be shouldered until after the target is visible. In other words, in case of a delay pull, the participant cannot call for the target and immediately shoulder the gun. The participant must wait for the target to appear.

#### f. Shotgun Shooting Rules

- (1) Safety and courtesy are first in gun handling; therefore, all guns will be carried unloaded, with actions open, and pointed in a safe direction.
- (2) Shotguns, shotguns with choke tubes as well as shotgun barrels, are not to be changed during the shotgun activity.
- (3) Cheek stocks or butt plates may be adjusted (taped) prior to event orientation. No further adjustments will be allowed once competition has begun.

#### **Hunting Shotgun Challenge, Con't.**

#### g. Legal / Illegal Targets

<u>Legal Target</u> – A whole clay target that is thrown form the trap in a prescribed pattern within the three (3) -second time limit after the participant calls for the target.

<u>Illegal Target</u> – A target broken by the trap or another obstruction. Illegal targets will be re-thrown for the participant, regardless of whether or not the participant fires at the target. Scorers will declare as soon as possible "no target". When doubles are thrown and one (1) or both targets are broken by the trap puller or are declared "no target" – both must be re-thrown and reshot.

#### h. Malfunctions

- **a.** The following occurrences will be considered malfunctions and new target(s) will be thrown:
  - Ammunition malfunction
  - > Trap or trap operator failure
- b. The following malfunctions will not be allowed and targets will be scored "lost":
  - > Participant error
  - ➤ Failure to load gun
  - > Failure of gun to fire (other than defective ammunition)
  - > Failure of gun to reload
  - Failure to select safety to off
- c. Should a gun break through no fault of the participant, another gun may be borrowed and the activity continued. However, if the breakage occurs during the firing at a target, and the target is missed, it will be scored as "lost".

In the case of an ammunition malfunction, the shooter must remain in place, the gun pointing safely down range, and must not open the gun or tamper with the trigger, safety or barrel selector until instructed to do so by the NRA staff or volunteer present.

The NRA staff or volunteer will determine if the firing pin came in contact with the primer. If the firing pin did, an ammunition malfunction will be called and the targets will be re-thrown. A second ammunition malfunction by the same participant will require the Event Director to determine if it is a gun malfunction or true ammunition malfunction.

#### 4. Hunting Light Rifle Challenge

- a. Participants will move through a rifle field course in a natural setting or stationary course whenever available. The course is designed to simulate shooting situations encountered while hunting.
- b. The Hunting Light Rifle Challenge will be conducted with participants shooting at NRA-approved action targets varying in distance, with scoring areas determined based upon type of target(s) used.

**Participants will shoot from three positions.** Time limit: 2.5 minutes per station with the complete course to be fired in 15 minutes. Participants may use props only provided by the event director.

**Position one (1) – (short range)** may have a distance of 30 yards or less.

Participants will shoot from a standing position with no props permitted at these distances. (NOTE: in certain circumstances specific to the range layout a prop maybe used at the discretion of the event director.)

<u>Position two (2) – (medium range)</u> may have a distance of 60 yards or less. Participants may use any shooting position (excluding prone) with the vertical post prop (if available) as the only aide.

<u>Position three (3) – (long range)</u> may have a distance of 75 yards or less. Participants may use any shooting position.

- c. **Scoring** Each participant will shoot a total of thirty (30) shots, each scoring ten (10) points each. Either life-size paper targets or NRA- action type targets will be used.
  - When using life-size paper targets, each shot which is within or touching the scoring ring designating the vital area of the game shall constitute a "hit" and will be scored as ten (10) points.
  - When using action type targets, "clangors", the target must flip completely over (360 degrees) to score ten (10) points, a shot that makes the target swing will score five (5) points. The score judge or range officer will be the final judge as to whether the target flipped, swung or has missed completely. Any discrepancies will be decided between the score judge, range officer and event director. Any call to challenge must be made before moving on to the next station. The Hunting Light Rifle Challenge has a maximum possibility of 300 points.

#### d. Rifle Equipment

#### Required

Participants may only use one rifle throughout the activity (exception – gun or scope malfunction)

#### **Permitted**

Only standard type .22 caliber rifles designed primarily for hunting will be permitted. It shall be the discretion of the MYHEC Officials to determine if a particular firearm is considered as a standard hunting style rifle.

#### **Hunting Light Rifle Challenge, Con't.**

- All action types, EXCEPT fully automatic, will be permitted. The rifle may not exceed eight pounds & 8 ounces (8.8) in weight without a sling and must have a minimum trigger pull of two (2) pounds (907 grams)
- ➤ Rifles may be equipped with a hunting sling not to exceed 1 1/2 inches (3.81 centimeters) in width. Slings must be attached at both ends of the firearm (forearm and butt stock) during the course of fire.
- ➤ Slings and scopes may be adjusted after the instructions and the order to commence firing at each station. Adjustments must be completed prior to the first shot. After the first shot at each station NO adjustments may be made. The maximum time for each station include any scope and /or sling adjustments.
- ➤ Adjustments to the scope include power and/or focus adjustments.
- > Rifles may also be equipped with sporter-type thumbhole stocks (non-adjustable).
- Sights will be open, peep with standard front post and bead, or hunting scopes, fixed or variable power optics nine power or less.
- ➤ All ammunition used in this activity will be .22 caliber long rifle cartridges. \* (See Available at Light Rifle Event Section below.)

#### **Available at Light Rifle Event**

- \*MYHEC will furnish all .22 long rifle ammunition to every participant. The specific manufacturer will be at the discretion of MYHEC official. If possible, MYHEC will notify participants of the specific type of ammunition to be utilized at the state event once received to facilitate advance rifle sight-in.
- ➤ A limited number of .22 field rifles with 4x scopes will be available to use at the light rifle event.

#### **Prohibited**

- Clothing with added padding, stiffness or shirt cup designed to assist shooter in remaining steady
- Shooting mats
- > Adjustable competition sling swivel
- Kneeling rolls
- Competitive thumbhole stocks
- ➤ Palm rests or forearm of stocks exceeding 2 ½ inches wide or 2 ½ inches deep as measured from the center line of the bore
- Scope, fixed, or variable power optics with capabilities greater than nine power.
  NOTE: Taping of scopes will not be allowed.
- Range finders
- Peep sights with rear aperture less than two millimeters

#### **Hunting Light Rifle Challenge, Con't.**

- Binoculars, monoculars or spotting scopes
- ➤ More than one shooting position per shooting sequence
- Shooting sticks, bipods or other similar equipment.
- > Stocks with adjustable combs
- Scopes with internal range finders

#### e. Crossfires

If a participant's target has been struck by more shots than fired by the participant, that target shall be declared as having been crossfired.

- The event director must determine that the crossfire was unintentionally caused (with no malicious intent) by participants on the firing line. If this is established, the crossfired target will receive the total score of rounds inside the scoring area (not to exceed the maximum score for that round of shooting). The participant committing a crossfire act will only be scored for the amount of rounds inside his/her actual target's scoring area.
- Should the Event Director find that the crossfiring was an intentional act by participants to gain unfair advantage, all parties involved will be immediately disqualified for the event and will subsequently receive "DQ" (amounting to '0") under both individual and team scores. Such individuals also subject to violation of the Code of Conduct and may be subject to disqualification for the entire State Event.

#### Rules and Regulations for Responsibility Events

#### 5. Hunter Responsibility Exam

a. Participants will complete a written examination that will include a number of objective questions (multiple choice, true & false, or fill-in-the-blank) determined by MYHEC Officials.

NOTE: This exam will be read aloud to accommodate participants with specific learning requirements.

- b. The Hunter Responsibility Exam consists of broad-based hunting and conservation information. NRA's publication, *The Hunter's Guide* will serve as the main reference text. It may be obtained by contacting the NRA Hunter Services Dept., 703-267-1503. *Michigan hunting field guides and Ducks at a Distance may also be used as resources to prepare for this exam.*
- c. Scoring Participants will be asked to answer all or as many questions possible in the allotted amount of time. Participants must answer all test questions with no assistance from other participants, written materials or coaches. Students will have 60 minutes (one hour) to complete the test. The Hunter Responsibility Exam will consist of 50 questions, with a maximum possibility of 300 points. The value of each question will be based upon the number of questions asked. (i.e. for a 60 question test each question would have a value of 5 points each.)

#### d. No Equipment Required

#### **Prohibited**

- Hunter education books
- ➤ Written, taped or transcribed information, and reference materials
- Use of cell phones, texting, or other forms of communications or communication
- ➤ Use of cell phones, texting or other forms of communications or communication devices between the participants, coaches or other individuals while taking the exam.
- Talking between two or more participants/coaches once exam has started (ONLY Exception: assigned MYHEC Officials may be called upon to clarify or to assist in reading for youth requiring such assistance.)

#### 6. Hunter Safety Trail Challenge

a. Participants will walk through a multiple station, pre-determined trail, designed to simulate actual hunting conditions and situations. Participants will be required to demonstrate their knowledge of hunter safety on this practical field course.

# NOTE: Participants will receive a MYHEC hunting license (valid for current MYHEC event only) and regulations at check-in.

b. The Hunter Safety Trail Challenge will be conducted with participants moving from station to station with each situation varying greatly. Participants may be tested and scored on the "do's" and "don'ts" of firearms safety and "shoot/don't shoot situations" encountered in a hunting environment. Stations may include, but are not limited to, hunter game situations, target identification, landowner relationships, and safe gun handling afield. NOTE: Participants may be required to be knowledgeable of game laws and bag limits. Information will be provided at event check-in.

# NOTE: Participants may be required to be knowledgeable of game laws and bag limits.

c. Scoring – Each participant may travel to several different stations with a given number of points at each. The Hunter Safety Trail Challenge has a maximum possibility of 300 points.

The value of each station will be dependent on the total number of stations to be encountered. (i.e. if the course would consist of ten (10) stations, each station would have a point value of 30.)

#### d. Equipment Required

- Arrive at the Safety Trail Challenge dressed as you would to legally hunt in Michigan. (i.e. wearing hunters orange, etc.)
- ➤ Bring your signed MYHEC hunting license (which you will receive in your registration packet or at Safety Trail check in) with you when you participate in the Hunter Safety Trail Challenge
- > Current DNR Hunting & Trapping Digest (will be provided to you at Safety Trail check in)

#### **Prohibited**

- Hunter education books
- Written, taped or transcribed information and reference materials
- ➤ Use of cell phones, texting or other forms of communications or communication devices between the participants, coaches or other individuals while on the course.
- ➤ No phones, cameras or video equipment are allowed at this event.
- Conversing with or coaching others about the Hunter Safety Trail event prior to all teams or individuals participation in the event. Coaches or participants witnessed conversing or coaching regarding the Hunter Safety Trail event may result in a noscore by the participants or coaches involved for the event.

#### 7. Hunting Orienteering Skills Challenge

- a. Participants will be required to demonstrate their knowledge of outdoor skills by completing a written test and use a compass to follow bearings to a pre-determined outdoor stations. A participant may request to have the written test read to them. NOTE: Time limits may be applied to each task.
- b. The Hunting Orienteering Skills Challenge will be conducted with participants taking bearings with their compass. Participants may also be asked to close a triangle, identify map symbols, or define words (i.e. contour lines, scale, or declination).
  - NOTE: All compass calibration & pacing checks must be completed at the Practice Area before entering the Orienteering Event.
  - Participants may be asked to describe how nature provides individuals with different directions of travel (north, south, east and west, etc.). These situations, as well as others, may be used in the Hunting Orienteering Skills Challenge (not to be announced before the program).
- c. Scoring Participants will be asked to demonstrate compass skills and complete a pre-determined number of written, map and field questions. The Hunting Orienteering Skills Challenge has a possibility of 300 point. The value of each station will be dependent on the total number of stations or questions established for the State Event. In addition, at the discretion of the MYHEC Officials, various aspects of this event may be awarded point values greater for certain tasks greater than other. (i.e. the point value of negotiating a pre-determined compass course may carry a higher point value of each leg greater than questions asked at other stations.)

#### d. Orienteering Equipment

- Only compasses may be used on the Hunting orienteering Skills Challenge course. The information for this event has been taken from:
  - NRA's The Hunter's Guide, (See Responsibility Exam Section for ordering information)

#### Hunting Orienteering Skills Challenge, con't.

#### **Permitted**

➤ Pacing Chart for yardage; card is not to exceed the size of a 3x5 index card and may include ONLY pacing conversions for the participant using the card.

#### **Prohibited**

- Calculators
- Orienteering books, encyclopedias, written, taped or transcribed information, and reference materials
- ➤ Electronic equipment including electronic or battery-operated compasses, PDA's, cell phones, radios, and other communication devices.
- ➤ Use of cell phones, texting, or other forms of communications or communication devices between the participants, coaches or other individuals while taking the exam. (ONLY Exception: assigned MYHEC Officials may be called upon to clarify or to assist in reading for youth requiring such assistance.)
- > Tripods or other means of support for compass
- > Range finders, binoculars, etc.
- > Crossing established boundary (marked with orange, red or yellow ribbon) lines.

#### 8. Hunting Wildlife Identification Challenge

- a. Participants will walk through a pre-determined number of stations in a field and/or woodland course in a natural setting whenever available.
- b. The Hunting Wildlife Identification Challenge will be conducted with participants observing North American game animal tracks, mounted (game or non-game) animals, and reading and identifying wildlife signs. All Specimens can be hunted or trapped somewhere in North America Wildlife will constitute mounted or tanned hides, depending upon availability. Animal tracks may be original or molds made of prints. Other wildlife signs may be real or reproduced.

NOTE: While the above reference materials will cover most questions and situations, the MYHEC officials reserve the right to have additional questions which may or may not be covered in these materials.

c. **Scoring** – Participants may be asked to identify up to 30 animals, tracks or wildlife signs, each worth 10 points for correct answers and zero for incorrect answers. The Hunting Wildlife Identification Challenge has a maximum possibility of 300 points.

# d. No Required Equipment Prohibited

- ➤ Wildlife identification books, encyclopedias, etc.
- Written, taped or transcribed information and reference materials
- > Electronic equipment
- ➤ Use of cell phones, texting, or other forms of communications or communication devices between the participants, coaches or other individuals while taking the exam. (ONLY Exception: assigned MYHEC Officials may be called upon to clarify or to assist in reading for youth requiring such assistance.)

#### VI. SCORING / TIE BREAKING CRITERIA

#### **Scoring Criteria for MYHEC Events**

Correctly answering a predetermined number of questions, making a certain number of hits in a prescribed target area, or correctly completing a prescribed activity accumulate event points. The maximum possible points for each event are 300.

Specific scoring criteria are provided as item (c) under each event section of this manual.

MYHEC follows the scoring criteria as it is established for the NRA's YHEC Program. Any changes and/or additions to these criteria are included in this manual.

MYHEC utilizes the rules and regulations (with some minor adjustments) and will provide eligibility for their participants to take part in the YHEC program. (i.e. Regional – Local, State, Provincial, or International levels.)

Individual scores will be compiled for each participant in the State Event. Individual scores will be compiled for each event and as an overall aggregate total of all events by participant's division of registration.

Team scores will be compiled as an aggregate score of all members of a team. Team scores will be compiled for each event and as an overall aggregate total for all events, by the participating teams division of registration.

#### **Tie Breaking Criteria for MYHEC Events**

Scoring ties for **all**\* individuals/teams per event, and overall will be broken. The following tie breaking criteria will be used in the MYHEC state event:

In the event of a tie,

1 - The individual/team with the highest level of achievement in the **Hunter Responsibility Exam** will be declared the winner(s).

If a tie remains,

2 - The individual/team with the highest level of achievement on the **Hunter Safety Trail Challenge** will be declared the winner(s).

Should a tie remain.

3 - The individual/team with the highest level of achievement on the **COMBINED** level of achievement in the **four (4) responsibility events** (Hunter Responsibility Exam, Hunter Safety Trail, Orienteering Skills Challenge, Hunting Wildlife Identification Challenge), will be declared the winner(s).

The final tie breaker will be based on

4 – The individual/team with the highest level of achievement on the **COMBINED** score of the **four (4) shooting events** (Hunting Shotgun Challenge, Hunting Light Rifle Challenge, Hunting Archery Challenge, Hunting Muzzleloader Challenge).

Should individuals/teams **tie in the Hunter Responsibility Exam**, the tie breaking formula will start at the second criteria – the Hunter Safety Trail Challenge.

Per International YHEC Rules and Regulations, all Regional, State and Provincial sponsors are **required** to use the tie breaking criteria as established above.

\*Ties for all categories, individual per event, overall individual scores, team per event and team overall will be broken.

#### VII. CHALLENGES/PROTESTS/ALIBIS

#### **Challenges During MYHEC Events**

Challenges concerning the value of shots as scored <u>must</u> be made immediately by the <u>participant</u> and will be resolved at each event. When shot value scores cannot be determined between the participant and the volunteer score judge, the Event Director will make the final determination. <u>Only participants may challenge and all challenges must be made during the challenge period</u>. (The challenge period is immediately before the next participant comes to the station or firing line or as outlined in the specific event regulations.)

#### **Protests During MYHEC Events**

Protests are to be brought to the attention of the Event Director. If the individual receives no satisfaction, a written protest may then be submitted to the MYHEC Protest Committee within two (2) hours of the protest, for review, consideration and final decision. The committee will be comprised of four (4) individuals (MYHEC Program/Event Director, NRA State YHEC Coordinator (whenever possible) and two (2) or three (3) assigned MYHEC volunteers.)

For MYHEC Shooting Events Only! If the participants protest is approved, the participant has the option of reshooting the entire event course or taking the score that they have already received. The participant must notify the NRA MYHEC Program Director of their decision immediately, upon notification of the protest decision.

Per International YHEC Rules and Regulations, all Regional, State and Provincial sponsors are **required** to handle protests as established above.

#### **Alibis During MYHEC Events**

Only range, trap, target or ammunition malfunction will constitute an alibi. Alibis will not be allowed for firearm, arrow or bow malfunctions. In the event of a firearm or bow malfunction, participants may borrow a firearm or bow and continue the relay. NO practice or sighting-in will be allowed for borrowed firearms once the NRA Michigan Youth Hunter Educational Challenge activities have begun.

Per International YHEC Rules and Regulations, all Regional, State and Provincial sponsors are **required** to use the alibi criteria as established above.

#### VIII. YHEC EVENT DATES

International YHEC rotates between the NRA Whittington Center in Raton, New Mexico and Mansfield, PA. The 2018 International YHEC event will be held at the Mill Cove Environmental Center, Mansfield, PA; July 22-27, 2018. #### IX. PARTICIPANT ENTRIES/CANCELLATIONS/TRAVEL

#### **Entries and Cancellations for MYHEC Participants**

The Michigan Youth Hunter Education Challenge Board of Directors will establish a date and location for the MYHEC State Event.

For State level participants to become eligible to participant in the current year's MYHEC program, an official NRA Youth Hunter Education Challenge International Registration Form, with accompanying copies of the participant's hunter education card, registration fee must be submitted to the MYHEC registrar by the deadline established below.

NOTE: For the 2018 MYHEC event, an individual may not alter their participation division after midnight on August 10, 2018. (See Section III, MYHEC Divisions – Participation Guidelines.)

All participant registrations and registration fees MUST be postmarked no later than August 1, 2018 to be eligible to participate in the current MYHEC event. Registration fees have been established to offset operational expenses (Such as but not limited to: ammunition, awards, targets, keepsakes, entry packet items and annual Scholarship presented each year to a college freshman.)

#### **MYHEC Participant Accommodations, Meals and Travel**

Any and all accommodations, meals and travel-related expenses incurred while participating in MYHEC will be the sole responsibility of participants / coaches.

#### X. ADDITIONAL INFORMATION

#### **Interstate Transportation of Personally Owned Firearms**

Federal law does not restrict an individual (except convicted felons, persons under indictment for felonies, mental defectives or incompetents, illegal users of controlled drugs, illegal aliens, veterans dishonorably discharged, those who have renounced their U.S. Citizenship, and fugitives from justice) from transporting firearms across state lines. Thus, there is no federal interstate transportation permit for firearms.

However, many states have laws governing the transportation of firearms. In addition, may cities and localities have ordinances restricting transportation of firearms. Travelers must be aware of these laws and compile with the legal requirements in each jurisdiction. Additional details on transporting firearms may be found in the NRA publication Guide to the Interstate Transportation of Firearms now available for download at http://www.nraila.org/gun-laws/articles/2010/guide-to-the interstate-transportation.aspx.

#### **Firearms Aboard Aircraft**

Federal law prohibits the carrying on any firearms, concealed or unconcealed on or about the person or in carry-on baggage while aboard an aircraft. Contact Your Relevant Airline Carrier Prior To Your Departure TO Obtain Up-To-The-Minute Regulations Regarding The Transport of Firearms.
